Parcel 5: That area bounded on the South by the Southern limit of the Municipality of St. Andrews, on the West by the Western limit of the Municipality, on the North by Fort Garry Road, and on the East by Provincial Trunk Highway # 8.

2. That By-law No. 3861 is hereby repealed.

THAT the proper officers of the Rural Municipality of St. Andrews are hereby authorized and directed to do all acts and things necessary for the proper implementation of the provisions of the within By-law.

## RURAL MUNICIPALITY OF ST ANDREWS . BY-LAW No. 3634

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF ST. ANDREWS TO AMEND BY-LAW NO. 3520.

WHEREAS the Rural Municipality of St. Andrews had on the 15th day of November 1983 passed By-law No. 3520, being a by-law prohibiting the discharge of certain firearms in certain areas of the Municipality;

AND WHEREAS it is deemed desirable, expedient and in the best interests of the Municipality to amend By-law No. 3520;

NOW THEREFORE the Council of the Rural Municipality of St. Andrews in session assembled enacts as follows:

1. That By-law No. 3520 be amended by adding the following paragraph immediately following Paragraph 1.(g):

> "(h) Pests incudes any wild bird commonly regarded as a nuisance in that it is injurious or destructive to property, including, without restricting the generality of the above, magpies and crows, but shall not include game birds;"

2. That By-law No. 3520 be amended by deleting Paragraph 4 and substituting therefore the following paragraph:

> "4. No person shall fire or otherwise discharge any firearm or high powered rifle within that area bounded on the north by the Town of Selkirk; on the east by the Red River; on the south by the southern limit of the Municipality; and on the west by the Canadian Pacific Railway right-of-way to Lockport Road and thence north following Provincial Trunck Highway No. 9, which area is indicated in yellow on the map attached as Schedule "C" hereto."

э. That By-law No. 3520 be amended by deleting Paragraph 7.(d) and substituting therefore the following paragraph:

> "(d) Owners of land in a specific area who are required to protect their property or pets from rodents, rabid animals or pests."

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF ST. ANDREWS TO AMEND BY-LAW NO. 3520.

RURAL MUNICIPALITY OF ST. ANDREWS BY-LAW NO. <u>3627</u>

WHEREAS the Rural Municipality of St. Andrews had on the 15th of November, 1983, passed By-law No. 3520.

AND WHEREAS the said By-law prohibited the discharge of certain firearms in certain areas of the Municipality and set maximum penalties for persons in breach of said By-law;

AND WHEREAS the Municipality wishes to provide for minimum penalties for the persons in breach of the said By-law, which provision will simplify the collection of fines from and the assessment of costs against those persons in breach of the said By-law;

AND WHEREAS it is deemed desirable, expedient and in the best interest of the Municipality to amend By-law No. 3520;

NOW THEREFORE be it enacted as a by-law of the Rural Municipality of St. Andrews:

That By-law ND. 3520 be amended as follows:

i) By deleting paragraph 8 of the said By-law and replacing it with the following paragraph:

"8. Any person guilty of a breach of the provisions of this By-law shall, upon summary conviction, be liable for a fine of not less than \$50.00 and costs and not more than \$500.00 plus costs, or in default of payment of any fine and costs levied to imprisonment for a period not exceeding three months and the provisions of "The Summary Convictions Act," Cap.S230 CCSM or any successive legislation thereto shall apply to any prosecution hereunder."

ii) That in all other respects the said By-law be confirmed.

2. That the proper officers of the Rural Municipality of St. Andrews are hereby authorized and directed to do all acts and things necessary for the proper implementation of the provisions of the within By-law.

BY-LAW NO. 3520

A By-Law of The Rural Municipality of St. Andrews regulating the firing of firearms.

WHEREAS The Municipal Act provides that Council of a Municipality may pass by-laws for preventing or regulating the firing of firearms within the Municipality or any part of the Municipality.

AND WHEREAS it is deemed necessary and expedient to pass a by-law regulating or preventing the firing of firearms in certain designated areas of the Municipality;

NOW THEREFORE THE COUNCIL OF THE RURAL MUNICIPALITY OF ST. ANDREWS IN SESSION ASSEMBLED ENACTS AS FOLLOWS:

- (a) Drain means any drain, drainage ditch, floodway or dike within the area;
  - (b) Firearm means any barrelled weapon from which any shot, bullet, or other missile can be discharged and that is capable of causing serious bodily injury or death to the person, and includes anything that can be adapted for use as a firearm;
  - (c) Game bird means birds of a species or type defined as a game bird in The Wild Life Act (Manitoba) as amended from time to time heretofore or hereafter by the success of legislation, or defined as a migratory game bird in the Migratory Birds Convention Act (Canada), as amended from time to time heretofore or hereafter;
  - (d) High powered rifle means any firearm which propels a single
    projectile from a centre fire cartridge but excludes a
    shot gun;
    - Highways means any place or way within the specific area as defined in Clause (u) of Subsection 2 (1) of The Municipal Act (Manitoba), as amended from time to time heretofore or hereafter;

Authorized personnel means specific designated employees
 of the Municipality, Conservation Officers, Royal Canadian
 Mounted Police Officers, or other persons who receive
 authorization from the Municipality;

(g) Predators means any animal which preys upon other animals or birds and which has or may kill or injure any farm or domestic animals within the Rural Municipality of St. Andrews.

2. Wherever the term "specific area" is referred to in this By-Law, the specific area shall refer to any area contained within those areas of the Municipality as described in paragraphs 3 and 4 herein and shall include any drains or highways contained within or on the boundary of that area.

3. No person shall fire or otherwise discharge a high powered rifle within the following part or parts of those portions of the Municipality contained within the dark lined perimeters as shown on the maps attached hereto and marked as Schedules "A" and "B" to this By-Law and more particularly:

Parcel 1: That area bounded on the South by the Southern limit of the Municipality of St. Andrews, on the West by Provincial Trunk Highway #8, on the North by the Northern limits of the Township 14-4 E.P.M. and Township 14-5 E.P.M. and the straight production Easterly thereof, and on the East by the Eastern limit of the Municipality of St. Andrews. (the West bank of the Red River) excepting thereout all those portions contained within the limits of the Town of Selkirk.

Parcel 2: That area bounded on the South by the Northern limit of Parcel 1 above, on the West by Provincial Trunk Highway No. 9 on the North by the Northern limits of Sections 25, 26 and 27 in Township 15-4 E.P.M. and of Sections 28, 29 and 30, Township 15-5 E.P.M. and on the East by the Eastern limit of the Municipality of St. Andrews (the West bank of the Red River).

Parcel 3: That area bounded on the South by the Southern limits of Sections 1, 2 and 3 in Township 17-4 E.P.M., on the West by Provincial Trunk Highway No. 9, on the North by the North limit of Section 22, Township 17-4 E.P.M. and it's straight production Easterly and on the East by Lake Winnipeg, excepting thereout all those portions contained within the limits of the Village of Dunnottar.

Parcel 4: That area bounded on the South by the Northern limits of Sections 21 and 22, Township 17-4 E.P.M. and the straight production Easterly thereof, on the West by the Western limits of Sections 28 and 33, Township 17-4 E.P.M. on the North by the North limit of Section 33, Township 17-4 E.P.M. and it's straight production Easterly and on the East by Lake Winnipeg, excepting thereout all those portions contained within the limits of the Town of Winnipeg Beach.

No person shall fire or otherwise discharge any firearm or high 4. powered rifle within the area outlined in red on a sketch attached as Schedule "C", which area is commonly known as "Simpson's Slough."

In the event that there are any discrepancies between the maps 5. attached hereto and marked as Schedule "A", "B" and "C" and the descriptions of land as set out in paragraph 3 above the enforcement of the provisions of this By-law shall be governed by the land described on the maps attached hereto as Schedule "A", "B" and "C".

Every person who fires or otherwise discharges any firearm or 6. high powered rifle contrary to the provisions of this By-law is guilty of an offence under this By-law.

- 7.
  - The provisions of this By-law do not apply to the following persons: (a) Authorized personnel in performance of their duties:
    - (b) Residents of a specific area while lawfully hunting predators within the said specific area;
    - (c) Persons authorized by Provincial Legislation to conduct trapping activities;
    - (d) Owners of land in a specific area who are required to protect their property or pets from rodents or rabid animals;
    - (e) Persons lawfully hunting game birds within the Municipality, provided that no person shall hunt game birds by use of firearms or high powered rifles within the area outlined in red attached as Schedule "A".

Any person who contravenes any provisions of this By-law is guilty 8, of an offence and shall be liable on summary conviction of a fine not exceeding Two Hundred (\$200.00) Dollars and in default of payment of any fine levied and costs, to a term of imprisonment for a period not exceeding thirty (30) days.

9. Notwithstanding that this By-Law may have passed third reading by the Council of the Rural Municipality of St. Andrews, none of the provisions contained herein shall be of any force or effect until such time as the Council of the Rural Municipality of St. Andrews, by separate resolution, authorize the implementation and enforcement of the provisions of this By-Law.
